The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

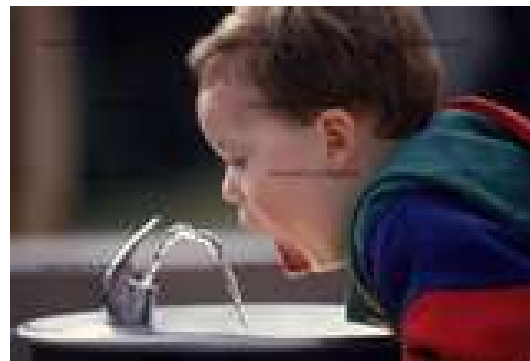
Contaminants that may be present in source water include the following: Microbial Contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. Inorganic Contaminants, such as salts and metals, which can be naturally-occurring, or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. Pesticides and Herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses. Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production and can also come from gas stations, urban storm water runoff, and septic systems. Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Princes Lake Water and Camp Atterbury's Directorate of Public Works routinely monitor for constituents in your drinking water according to Federal and State Laws. In order to ensure that tap water is safe to drink, the Indiana Department of Environmental Management and the US Environmental Protection Agency (EPA) prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Contaminants may be found in drinking water that may cause taste, color or odor problems. These types of problems are not necessarily causes for health concerns. Camp Atterbury is pleased to provide this consumer confidence report describing the quality of the drinking water provided from January 1st to December 31st, 2016. Camp Atterbury is committed to providing you with information you need to know about the water you drink and the efforts to provide safe drinking water. Camp Atterbury's water is purchased from the Princes Lake Water Department. Princes Lake's PWSID Number is IN5241007. Princes Lakes supplies water to Camp Atterbury from a ground water source. The ground water is pumped from a group of wells north of the town of Edinburg, Indiana. The wells draw from the Scottsburg Lowland Aquifer.

We are proud to report that Princes Lake Water Department had no violations during 2016. Further, Camp Atterbury had no violations during 2016. Some contaminants are sampled less frequently than annually. The results provided are from the most recent sampling event.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Water Quality Test Results/Definitions

The tables list all the contaminants detected during the 2016 calendar year. As you can see by the table, our systems had no violations. The tables contain scientific terms and units of measure, some of which may require explanation:

- MCL: Maximum Contaminant Level, the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- MCLG: Maximum Containment Level Goal, the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- MRDL: Maximum Residual Disinfectant Level, the highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- MRDLG: Maximum Residual Disinfectant Level Goal, the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- pCi/L: Picocuries per Liter (a measure of radioactivity).
- mrem/yr: Millirems per year (a measure of radiation absorbed by the body).
- ppm: Parts per million or milligrams per liter (mg/l) – or one ounce in 7,350 gallons of water.
- ppb: Parts per billion or micrograms per liter (ug/l) – or one ounce in 7,350,000 gallons of water.
- AVG: Average, regulatory compliance with some MCLs are based on running annual average of monthly samples.
- na: Not available or not applicable.
- Level 1 Assessment: A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
- Level 2 Assessment: A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
- TT: Treatment Technique, a required process intended to reduce the level of a contaminant in drinking water.
- AL: Action Level, the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.
- ALG: Action Level Goal, the level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Camp Atterbury is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
